

Malaysian companies are interested in investing in the Almaty region

At the site of the Regional Development Center of the Almaty Region in Almaty, a meeting was held between representatives of the Almaty Region Akimat and the delegation of the International Trade Association of Small and Medium Businesses of Malaysia (SMITA).

The Kazakhstan side was represented by adviser to the Embassy of the Republic of Kazakhstan in Malaysia, Serik Amirov, head of the UPIRID of the Almaty region Ruslan Kozhasbayev, chairman of the board of RIR SPK Zhetysu JSC Talgat Malybaev, first deputy chairman of the board of RIR SPK Zhetysu Yergazy Orymbasarov and deputy director of the Regional Center development of Almaty region Chingiz Makashev.

The Malaysian delegation was represented by SMITA Director General Megane Soo and top managers of engineering, biotechnological, industrial and food companies.

In his welcoming remarks, the head of UPIID, Ruslan Kozhasbayev, spoke about the investment opportunities of the region and emphasized that the climatic and logistical conditions make it possible to implement various projects in the field of entrepreneurship.

Further, Talgat Malybaev, Chairman of the Board of RIR RJK SEC Zhetysu, noted the main tasks of the SEC, and spoke in more detail about ongoing projects.



“Our corporation provides support to entrepreneurs in the field of agriculture, subsoil use, tourism, roadside services, green energy and industrial zones. We are the connecting link between the state and business. There are 6 industrial zones in the Almaty region, of which two zones in the Talgar and Ili district ah have a lot of investment projects. The conditions for the implementation of projects and measures of state support were explained to the delegation.

In turn, SMITA Director General Megane Soo thanked the regional akimat for the warm welcome and noted that Kazakhstan has an attractive investment climate.
